

Beginning on June 13th 2017

June 13, complaint received from Colorado Committee to Restore Green Values; acknowledged with 24 hours.

Follow-up among AC; first thought was for a small group to take it up, then involved entire committee.

Response received June 26th.

June 28, received word that Dave Bell (Respondent) told the Complainants that the clock had not started ticking on the complaint process. According to the AC, the clock started when the complaint was received, June 13.

July 9, Call with GPCO Committee to Restore Green Values.

July 10, Call with GPCO Respondents.

July 11, received screenshots of documentation from Respondents regarding management of state party committee forum.

July 11, contacted GPCO Respondents to assure them the AC was not planning to move toward a disaffiliation proposal at this time. Respondents had stated they believe they are in the majority, and their wish was to discuss and resolve various issues at the upcoming state meeting August 12th.

July 11, received additional screenshots from the Committee to Restore Green Values.

July 13, received forward of correspondence between Harry Hempy (RGV) and Sean Friend (GPCO Secretary).

July 13, GPCO Proposal to ban Harry Hempy.

July 14, received information about proposed ban of one of the Complainants (RGV).

July 14, AC sent Report, Findings and Recommendations to GPCO, Complainants and GPUS SC.

July 14, Co-chair of GPCO thanks AC co-chair for being fair; co-chair notes that the AC is attempting to provide a framework to help resolve problems without recriminations

July 15, message from Michael Haughey (RGV)

July 1, GPCO co-chair objects to AC's Report. Several AC members state they stand by it.

July 19, GPCO co-chair asks AC co-chair for names of complainants. AC co-chair provides names.

July 23-24, received message from Judy Harrington (RGV) about more chapter dissolutions and proposed ban on herself.

July 25, AC conference call II.

July 26, received attached information regarding proposal to ban Hemy.

July 27, AC Conference Call III.

July 28, RGV Response to AC Questions; messages regarding Hemy ban.

July 28, AC agrees by unanimous consensus to ask George Friday to attend the August 12th GPCO state party meeting as an observer.

July 29, AC request for travel and related funds for George Friday's attendance at GPCO state meeting sent to GPUS Secretary.

July 30, received more information on status of a GPCO proposal; screenshots/

July 30, received language for proposal re state level.

July 31, AC Request for Observer Travel Funds submitted to GPUS SC.

ca. above, Harrington banned from GPCO.

August 5, Hemy's good standing in GPCO revoked.

ca. August 6, SC votes down request for travel funds.

August 9, question about statement made on SC call or list, that the GPCO officers were surprised and previously unaware of AC request for an observer to their state meeting; provided documentation that the AC had communicated request on July 14th, and documentation that this had been referred to, and therefore known by, GPCO officers)ca. July 23rd.

August 8, Hemy participation revoked

August 8, requests from RGV to have an observer at the credentialing table for GPCO state meeting; concerns that individuals technically ineligible to vote per GPCO bylaws will be allowed to vote, while RGV committee members are excluded

August 9 or 10, GPCO officers exclude RGV from observing credentialing, in response to Haughey's requests that observers be allowed.
