I think we should be able to agree to a reasonable compromise and level of accomodation. I agree with Andrea that other voices from our contingent need to be heard. Specifically, the voices of Harry Hemy and Judy Harrington need to be heard. Harry Hemy has been duly nominated as a candidate for state co-chair of the Green Party of Colorado. Judy Harrington has been duly nominated as a candidate for national delegate.

The Green Party council violated state party bylaws by revoking Judy Harrington and Harry Hemy's rights of participation in the Green Party of Colorado without an open hearing at the party's state meeting, with the right to face their accusers and publicly defend themselves against the absurd charges that were leveled against them. The state council violated the Green Party of Colorado's bylaws by suspending the Platte Valley and Jefferson County chapters from active status. These resolutions were invalid. They are therefore null and void. If the regime that currently controls the Green Party of Colorado acknowledges this fact, recognizes that the Platte Valley and Jefferson County chapters remain active party affiliates, and recognizes that Harry Hemy and Judy Harrington remain GPCO members in good standing who have been duly nominated for state party offices, then we could save some time at the state meeting. The three resolutions to reinstate the Jefferson County and Platte Valley chapters, and to restore the membership rights of Harry Hemy and Judy Harrington would become unnecessary.

Hi Michael,

This is not about whether or not there is a deadline. It is about the fact that the meeting planning thread has been open to all council members for almost four months. You have not attempted to participate in that process in any capacity, and then one week before the meeting, you bypassed the council proceeding and emailed the secretary demanding that 11 proposals be added to the meeting agenda. This request is unreasonable, and I honestly do not agree with your assertion that these proposals are neither long nor difficult to understand. If each of these proposals is given 10 minutes for presentation, discussion, consensus building, and voting, that process will take nearly two hours of meeting that is five hours and forty five minutes long. That is too much time to demand on this limited notice, especially considering the fact that you have chosen not to collaborate in this process at all.

You were presented with three reasonable compromises two days ago and have still not demonstrated any willingness to consider them. I urge you to decide which of these options you would like to choose soon, or offer some other option that takes the existing circumstances into consideration.

Hi Sean,

No deadline was announced for proposals. Historically proposals have been taken from the floor at annual meetings. That is the way of democracy. Our proposals are neither long nor difficult to understand. Please post and announce them if that has not already been done.

The applicable rules state:

By-Law 4.2.4. All decisions of the Council are subject to review at the next state meeting and may be overturned by a 60% vote.

Procedures and Guidelines 3.2.5. Proposals brought to the agenda of a state meeting must be made by local chapters or a minimum of 5 individuals at large, by the Council, or by any Officer of the GPCO. A written statement of the proposal must be sent to the Council by a representative of the sponsoring local, or by a member at large accompanied by evidence of at least 4 other member's endorsements. The statement and evidence may be done by email or on paper.

Good afternoon folks,

I'm seeing eleven proposals here and it's less than a week before the state meeting. Each of these proposals are going to require a significant amount of discussion, amendment, and consensus building even before going to a vote, even if there were no procedural issues with them (and I see several). There's no way that we can effectively accommodate such a large number of proposals in the thirty minutes currently scheduled for proposals and resolutions, even if there were no other proposals on the floor (there are already four). I see three options at this point:

1. A local runs these proposals through the Council (especially since many of them are related to Council operations and structure).
2. Your group chooses two or three proposals that you would like to put on the floor, with the understanding that time for discussion will be severely limited.
3. All eleven proposals are brought to the floor for a simple up/down vote.

Please let me know how you would like to proceed. I've copied the Co Chairs on this email so they are aware of the proposed agenda changes.
